

AFTER HOURS POLICY

If arriving after hours, please advise the marina office and Dockmaster of estimated time of arrival at least 24 hours in advance. You will be assigned a slip number and required, the Dockmaster will be available to assist and our security team will be made aware of your arrival.

*After hours arrival is dependent upon weather conditions. Inbound traffic will be closed should wind be greater than 15 knots.

CUSTOMS AND IMMIGRATION


All vessels must provide the following information:

□ Crew and Passenger List

- □ Last port of call clearance documents
- □ Vessel Registry
- □ ETA/ETD
- □ Next port of call
- With this information supplied in advance, passports will be stamped on arrival. Guests are free to roam immediately upon entering the Federation of St Kitts and Nevis.

If the vessel is to dock overnight, the following documents will be required prior to arrival:

- □ Insurance Certificate
- The Marina at Christophe Harbour Berthing Agreement
- Copy of Captain's Passport
- □ Vessel Credit Card



MOORING

The Marina at Christophe Harbour team will greet your vessel outside the harbour in the tender with information regarding weather conditions, berth arrangement, other vessels in the vicinity, and any potential hazards. Marina staff will also be positioned at your specified berth to handle lines and secure the vessel safely. The marina tender will be available to assist where required.

DUTY-FREE FUEL

The Marina at Christophe Harbour offers tax and duty-free fuel to both private and commercial vessels. In-slip fuelling* is available for vessels up to 250'.

- Ultra low sulphur diesel
- 125 US gallons per minute
- 44,000 US gallons onsite (24 hours notice required subject to availability)
- Deliveries in excess of 55,000 US gallons will be handled over multiple days (48 hours notice required)
- Gasoline and diesel fuel are located at the tender dock

Water spigots are conveniently located for each berth: 2 water spigots in the pedestal; 1 on dock finger.

INTERNET SERVICES

All dock pedestals have high speed internet capabilities dedicated for each vessel. Simply log on to "Marina Wi-fi" and register your device. Password will be issued in arrival packet.

TENDER DOCK

A 240' floating arrival dock is available for use as needed by vessels in the marina or in our anchorages. Gasoline, diesel and water are available at this dock during office hours.

ISPS SECURITY

The Marina at Christophe Harbour has security staff positioned at the dock gatehouse and marina entrance 24 hours / 7 days. Call +1 869.762.0771 for assistance.

GARBAGE

Garbage will be collected from vessels daily during operating hours. All garbage should be double bagged. Please inquire regarding recycling capabilities.

PARKING

Owners and guests of The Marina at Christophe Harbour have parking access located a short distance from the dock. Arrangements for rental car(s) to be onsite upon vessel arrival can be requested with 24 hour notice.

CONCIERGE SERVICES

APA BANKING

Marina Guest Services is well suited to anticipate both guest and crew needs, allowing all aboard to spend their time discovering and experiencing all that Christophe Harbour has to offer. Our experienced staff will serve as a primary point of contact for any service you may need during your stay.

PROVISIONING

Should your vessel need provisioning services, please contact the marina office for a provisioning form. Some items subject to seasonal availability and may require 7 days notice. For banking services please contact the marina office for bank account details and we will arrange delivery of the funds to the boat by security courier. Most currencies are available for exchange via the Eastern Caribbean Central Bank.

TRANSPORTATION

Courtesy transportation is complimentary throughout Christophe Harbour for marina guests. We can also arrange airport pickup or ground transport elsewhere on island to ensure our guests arrive comfortably, swiftly, and safely to their final destination. Rental cars available with 24 hours notice.

DEPOSITS

Dockage reservations require a 50% deposit at the time of booking. The deposit is applied toward your dockage upon your request or final departure.

CHANGE POLICY

Changes in the length or dates of your reservation must occur within 24 hours. Changes after this deadline will result in one night dockage fees and canceled reservation.

INVOICING

Dockage is determined by a vessel's given rate per linear foot multiplied by nights of stay. Dockage rates are exclusive of utility, garbage, water, security, and admin charges. Every vessel will be presented with an invoice at departure. A valid credit card must be provided at arrival which authorizes the marina to settle all outstanding invoices.

CANCELLATION

Cancellations within 72 hours of arrival warrant a full deposit refund. No refund will be issued if cancellation occurs after stated deadline.

THE PAVILION




YU LOUNGE
